Nikko Asset Management Measures in Response to Declaration of State of Emergency in Japan

Nikko Asset Management Co., Ltd. (Nikko AM) is carrying out the following measures to ensure business continuity, following the declaration of a state of emergency on 7 April by the Japanese government regarding Tokyo and six other prefectures.

Nikko AM has made a number of preparations before the state of emergency was declared in order to ensure uninterrupted investment management and other services. This includes decentralising various functions between our business continuity planning sites and giving all employees the tools to work from home protected by the same information security they have in the office. Even before the declaration, many employees had already shifted to working from home.

In response to the declaration, to preserve the operations of financial markets as a key component of societal infrastructure, as well as Nikko AM's role as a fiduciary, we are encouraging all employees to work from home, with the exception of the minimum number of staff whose roles require them to be in the office. Therefore, our teams are prepared and capable of providing as usual all the necessary capabilities for investment management, including calculating net asset value. Furthermore, the assets invested that make up the investment trusts are managed separately from other assets at each respective custodial bank, in accordance with all related regulations.

Nikko AM adheres to the state of emergency, and is making every effort to minimise the spread of the coronavirus and its impact on the health and safety of our customers and stakeholders, employees and their families, while preserving the same level of high-quality service.
