Investment Objective

The investment objective of the Fund is to achieve medium to long term capital appreciation by investing primarily in listed equities of corporations listed on the Recognised Stock Exchanges* in any part of the world (as may from time to time be agreed between the Managers and the Trustee) and which carry on significant business in, whose operations are in, or which derive substantial revenue from, or whose subsidiaries, related or associated corporations derive substantial revenue from PRC. The investments of the Fund will be broadly diversified with no specific industry or sectoral emphasis.




